5. ELIGIBILITY CRITERIA FOR ADMISSION

All residents of India fulfilling the eligibility criteria mentioned below can apply to Rajasthan University of Health Sciences for RUHS Post Basic Diploma in Nursing - Advance Course Entrance Exam 2025 for admission to Post Basic Diploma in Nursing - Advance Course in Constituent College & affiliated Colleges to Rajasthan University of Health Sciences, Jaipur, on the basis of instructions given in this information booklet, the relevant rules of RUHS, Jaipur and directions of State Govt./ Honorable Court.

For admission to Post Basic Diploma in Nursing - Advance Course 2025 in colleges affiliated to RUHS, Jaipur, it is **mandatory to appear in the RUHS Post Basic Diploma in Nursing - Advance Course Entrance Exam 2025**

5.1 Non-Service Candidates

- 5.1.1. Should have passed the Higher Secondary or Senior Secondary or Intermediate or 10 +2 or an equivalent examination recognized by the University for this purpose. Those who have done 10+1 in or 1986, will be eligible for admission.
- 5.1.2. Be a registered nurse and midwife (R.N. & R.M.) GNM/B.Sc. Nursing or equivalent with any State Nurses' Registration Council (SNRC) having NUID number.
- 5.1.3 Be physically fit.
- 5.1.4 Selection will be based on the merit of Post Basic Diploma in Specialty Nursing Entrance Exam 2025.
- 5.1.5 Nurses from other countries must obtain an equivalence certificate from the Council before admission.
- 5.1.6. The candidate should have undergone GNM or B.Sc. Nursing with institution which is recognized by Indian Nursing Council/State Nursing Council.

Note: Candidates must have registered as RNRM with State Nursing Registration Council and One year clinical experience till last date of filling online application form.

5.2 In-Service Candidates (Only for Rajasthan State Government / RUHS Employee)

In addition to the eligibility criteria prescribed for non-service candidates, in-service candidate must also fulfill the eligibility criteria as below:

- 5.2.1. The candidate should be In-Service of State Government of Rajasthan.
- 5.2.2. The candidate should have completed at least two years of continuous service after regular appointment by State Government of Rajasthan. The candidate would be required to submit a certificate (**Appendix A**) to the above effect duly signed by the Director, Medical & Health Service/Joint Director (Zone).
- 5.2.3 The certificate submitted by the In-Service Candidates should clearly indicate that the person concerned is serving the Government of Rajasthan for at least 2 years (as on the last date of submitting the on-line application form), after regular appointment failing which the application form will be considered as non-service category candidate.

6. AGE LIMIT

There is no age limit for admission to RUHS Post Basic Diploma in Nursing - Advance Course Entrance Exam 2025

7. RESERVATION

The reservation of seats will be made subject to statutory provisions of Govt. of Rajasthan for Rajasthan domicile candidates. Candidates belonging to reservation categories of states other than Rajasthan shall be allotted seats in the unreserved category.

Candidates will be required to submit the Caste Certificate, Caste Validity and Non Creamy Layer Certificate, if applicable, at the time of filling Online Application Form and at the time of joining allotted college to be considered under the category.

Note:-

- The reservation of seats will be made subject to statutory provisions of Govt. of Rajasthan for Rajasthan domicile candidates. Candidates belonging to reservation categories of states other than Rajasthan shall be allotted seats in the un-reserved category.
- Candidates seeking benefit of reservation shall be required to produce for verification, at the time of joining at the allotted college, the original certificate (SC, ST, ST-STA OBC Non creamy layer, MBC Non creamy layer, EWS) or the additional category certificate (PwD, if applicable) issued by the competent authority and submit attested copies of the above documents.
- OBC/MBC candidate must submit original OBC/MBC Certificate for Rajasthan State issued by competent authority of Rajasthan (issued within last one year of the date of conduct of the Post Basic Diploma in Nursing - Advance Course Entrance Exam 2025 and clearly indicating 'Non Creamy Layer') at the time of joining.
- EWS candidate must submit original EWS Certificate for Rajasthan State issued by competent authority of Rajasthan (valid for financial year 2025-26) at the time of joining.
- PwD reservation: 5%** seats shall be reserved on Merit-cum-Priority in each category horizontally in accordance with Annexure 1. On the notified date, the PwD candidate must produce PwD certificate (issued by Competent Authority) during physical disability verification before the Medical Board constituted by RUHS, Jaipur for the purpose.

All reservation will be applicable only for Round 1 and Round 2 counseling process. During Round 3 and or Open Round counseling, there will be no reservation applicable. All candidates will be treated as unreserved.

All reservations policies are applicable as notified by Government of Rajasthan from time to time.

8. DOMICILE CRITERIA

Admission to the course is open to all residents of India.

9. MEDICAL FITNESS

- Candidates shall be medically fit.
- A candidate desirous of admission will have to deposit the medical fitness certificate at the time of joining at the allotted college on the prescribed form certified by a medical officer of the Government of Rajasthan as per the medical standards.

10.1 The percentage of female candidates shall not fall below 50% of the total seats in all categories.

10.2 The percentage of in-service and non-service candidates seats division is 50–50% as per vide Govt. Order No.F7 (Budget A. 2025-26)/DME/PARA/2025/PART-1/04701 dated 04-12-2025.

- 10.3 In all the RUHS affiliated nursing colleges, 100% seats (of the intake sanctioned) shall be filled through RUHS Counseling / Admission Board 2025.

11. FEE STRUCTURE

For the academic session 2025-26 the candidates are required to pay the fee as prescribed by State Government from time to time, for the course.

12. APPLICATION PROCEDURE

- 12.1 Before filling the on-line application form, read the information booklet and instructions for filling on-line application form etc. very carefully. Ensure the eligibility and other requirements for admission as given in this information Brochure.
- 12.2 Candidate should be very careful in filling-up the on-line application form. If any lapse is detected during the scrutiny, candidature will be rejected even if candidate comes through the final stage of admission process or even at a later stage.
- 12.3 If a candidate fills two or more on-line application forms, the last filled and completed application form will be considered for further processing.

13. IMPORTANT POINTS

- 13.1 Hand Written / Typed / Photostat Copies / Printed Application Form / Screen Printout will not be entertained.
- 13.2 Follow the steps as given in “Instructions to fill up on-line application form” available at the website.
- 13.3 Note the ID and password for further steps. Keep it safe.

14. ADMISSION TEST

- 14.1 The entrance examination of 120 minutes duration in English as well as Hindi language will be conducted (at the examination center) at Jaipur only. If any discrepancy is found in any question, then the English version will only be considered. The details of the admission test will be available at the RUHS website.
- 14.2 The entrance examination for seeking admission in Post Basic Diploma in Nursing -Advance Course 2025 shall be on the standard of GNM course
- 14.3 Following subjects shall be included in Tentative guidelines of RUHS Post Basic Diploma in Nursing - Advance Course 2025:
- Anatomy & Physiology, Microbiology, Psychology, Sociology, Fundamental of Nursing, First aid, Personal Hygiene, Medical Surgical Nursing, Community Health Nursing, Health Education, Communication Skills, Nutrition, Midwifery & Obstetrical Nursing, Child Health Nursing, Mental Health Nursing and nursing research.
- 14.4 There shall be 120 objective type questions.
- 14.5 Each question shall have four options to answer, out of which only one shall be correct. (+1) mark shall be awarded for each correct answer, (0) mark for an incorrect answer or un-attempted questions. There shall be no negative marking.
- 14.6 Admit card with relevant instructions shall not be sent by post and will be available for downloading at the RUHS website.
- 14.7 All candidates are required to appear in the admission test at their own expenses. No TA/DA will be paid the purpose. The appearance in the admission test will not confer any right upon the candidate to be admitted to Post Basic Diploma in Nursing -Advance Course 2025.
- 14.8 Candidates trying to use unfair means shall be disqualified from the admission. No correspondence whatsoever will be entertained from the candidates.
- 14.9 The RUHS / Admission Board reserves the right to create cities / Centre(s) for RUHS Post Basic Diploma in Nursing -Advance Course 2025 and also to call the candidates for the RUHS Post Basic Diploma in Nursing -Advance Course 2025 at any city / Centre, other than the one mentioned in the information booklet.

15. CHOICE FILLING / COUNSELING FEE

After appearing in the RUHS Post Basic Diploma in Nursing -Advance Course 2025. , to participate in the counseling process, candidates will be required to fill choices of the course and college (in order of preference) by paying counseling fee (non-refundable) as mentioned below.

16. ADMISSION PROCEDURE

16.1 The admissions shall be made strictly in accordance with merit list prepared on the basis of score of the entrance test and the order of choices / options filled in by the candidates in the on-line choice filling form. The candidates are advised to exercise their choices / options very carefully.

Note:

- For the entrance test, separate instructions / guidelines will be provided to the candidates through RUHS website. RUHS reserves the right to decide about mode of admission. The decision of RUHS/Counseling Board shall be final and binding to all. Candidates are advised to secure information regarding the admission from the website of RUHS (www.ruhsraj.org).

Important to note: If at any stage, it is found that a non-eligible candidate is admitted to a course, then the admission of such a candidate will be cancelled on such detection. A penal action may also be initiated against such candidate.

17. ALLOTMENT OF COLLEGE

17.1 The allotment of college and course shall be made by strictly following the order of merit, seats available in each college and the priority of choice/option of the college and the course filled-in by the candidate in the on-line application form.

17.2 Candidates securing equal score in the admission test will be admitted in the following order of preference:

- One who has passed GNM/B.Sc. Nursing examination in less number of attempts.
- The candidate of higher age (older candidate).
- One who has obtained higher total marks in Higher Secondary or Senior Secondary examination respectively.

17.3 After allotment of college and course, candidates will be informed about their allotment at RUHS website. Candidate is required to take a printout of the

allotment letter / information and join at the allotted college with this printout along with requisite documents, in original, and prescribed fee, by the notified date.

- 17.4 The non-viewing of the RUHS website about allotment information by the candidate shall not be accepted as a ground for not submitting the option form or non-joining at the allotted college on the scheduled time and date. The candidate's allotment will stand automatically cancelled if he/she does not report IN PERSON to the allotted college as per notified schedule.

18. JOINING AT ALLOTTED COLLEGE AND DEPOSITING OF FEES & OTHER DOCUMENTS

- 18.1 At the time of joining at the allotted college, the candidate will have to carry printout of the allotment letter. The candidate is required to deposit the prescribed fee along with original and one set of attested photocopies of requisite documents.
- 18.2 The colleges shall be provided the list of candidates allotted. The colleges shall verify the credentials of reporting candidates as per this list and check the documents and other required certificates with originals.
- 18.3 In case of non-reporting / non-joining by the candidates at the allotted college in round 1, candidate shall not be eligible to participate in subsequent round(s) of online counseling / admission process or as decided by RUHS.
- 18.4 **Conditions relating to bond (applicable for Government colleges/ Government Self-Financed College)**

19. ADMISSIONS ON THE VACANT SEATS, DROP-OUT SEATS

- 19.1 After 2 rounds of on-line counseling, if seats remain vacant either due to exhaustion of the merit list or due to non-joining of candidates at the allotted college, RUHS Admission / Counseling Board reserves the right to take appropriate decision to fill the seats remaining vacant.
- 19.2 **IT IS CLARIFIED THAT RUHS AFFILIATED COLLEGES SHALL NOT FILL ANY SEAT DIRECTLY AT THEIR OWN LEVEL.**
- 19.3 **NO ADMISSION SHALL BE MADE AFTER THE DATE AS MAY BE NOTIFIED BY RUHS/ ADMISSION BOARD.**
- 19.4 The admissions shall be treated as provisional subject to the final decision of any pending case(s) in any court of law, if applicable to these admissions. Further, the provisional status of admission shall be confirmed only after enrolment by the RUHS after document verification at the level of RUHS (documents as submitted by the candidate).
- 19.5 Any circumstances-based decision relating to the admission / counseling process may be taken by the Chairman E & R Cell, RUHS or Chairman Admission / Counseling Board, RUHS which shall be final and binding on all concerned.

- 19.6 All the judgments relevant to these admissions, passed by any Hon'ble court of justice as well as rules existing at the time of making admissions will be applicable on these admissions and the candidates will have to abide compulsorily with such judgments, rules and the changes.

20. CANCELLATION OF ADMISSION AND REFUND OF FEES, RETURN OF DOCUMENTS BY INSTITUTIONS

- 20.1 The Candidate shall apply for cancellation of admission by submitting duly signed application to the allotted Institution before the start of last round of counseling process. The Institute shall consider the request made by candidate for cancellation as final. Upon such cancellation, the candidate shall lose the claim on the seat and such seat shall become available for further allotment. The Institute shall refund the fees to the candidate after deduction of **Rupees one thousand only towards processing charges and return all his/her original documents submitted to the Institute within two days from submission of duly signed application.**
- 20.2 Candidate shall not be entitled to any refund of his/her fee except the Security Deposit / Caution Money Deposit if the cancellation is effected by the candidate after of the cut-off date by RUHS.
- 20.3 No institution, who has in its possession or custody, any document in the form of Certificates, Degree, Diploma or any other award or other document deposited with it by a person for the purpose of seeking admission in such institution, shall refuse to return such Certificate, Degree, Diploma, award or any other document with a view to induce or compel such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue or avail any facility in such institution.

The apex court drew guidelines for the management of all educational institutions to follow. Among them:

Educational institutions should take anti-ragging measures right from the time of advertisement for admissions. The prospectus, the form for admission and/or any other literature issued to aspirants for admission must clearly mention that ragging is banned in the institution and anyone indulging in it is likely to be punished appropriately which may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology.

The punishment may also take the shape of:

- (i) withholding scholarships or other benefits
- (ii) debarring from representation in events
- (iv) withholding results
- (v) suspension or expulsion from hostel or mess.

If there be any legislation governing ragging or any provisions in statute/ordinance, it should be brought to the notice of the students/parents seeking admissions. A printed leaflet detailing when and to whom a victim may turn for information, help and guidance for various purposes, keeping in view the needs of new entrants, along with their addresses and telephone numbers should be given to fresher at the time of admissions so that they need not to look to seniors for help in such matters.

- Note : 1. The “Certificate of Disability” shall be issued in accordance with the Rights of Persons with Disabilities Rules, 2017 notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 15th June 2017.
2. The extent of “specified disability” in a person shall be assessed in accordance with the “Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016 (49 of 2016)” notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 4th January 2018.
3. The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability.
4. **The term ‘Persons with Disabilities’ (PwD) is to be used instead of the term ‘Physically Handicapped’ (PH).**
